

Dare I ask as usual, therefore, if you generally wintered well in the circumstances and whether you managed, at least some of the time, to enjoy yourself, in spite of unresolved matters hovering over some of us? Whilst preparing the Autumn FAN, I was watching my incoming e-mails especially carefully so as not to miss any news on our company registration front to be able to impart some good news in

the run up to Christmas. Well, just when I thought that I must send the FAN file to the printer to meet the promised availability already announced on the website, the news awaited with bated breath arrived. With much satisfaction and especially with thanks to Diane, I was able to use the phrase 'STOP PRESS' for my first time. I announced on the front page of the Autumn FAN that Families Anonymous UK had officially established its Company Limited by Guarantee. For those interested in the detail, the company is called The Service Office of Families Anonymous (UK, Eire and Gibraltar) Limited with Registration no. 8286152.

#### **TOWARDS BECOMING A CHARITY**

The feeling of elation was temporarily tempered, because a couple of weeks into January, at the time that I was starting this 'welcome page' in this Spring 2012 FAN, we received a demanding answer from the Charity Commission to our application for charity status. Well, I am glad to report now that the demands of the Commission are hopefully near the end of their processing through the good offices of our Treasurer, Diane, and our lawyers seeing the way through, together with the Charity Commission. A stumbling block was that the company name that we had chosen - which was as above, except that the words Service Office were originally Board - was unacceptable. The word Board turned out to be unsuitable for legal reasons within our formal company name, although perfectly acceptable in the way we generally use it at present. Thankfully, that is now water under the bridge and the Commission and our lawyers have agreed on the wording of the Articles of Association of our company. Our Fellowship's By-Laws need updating to reflect the existence of our new company, and will be voted by the Fellowship's group delegates at the imminent AGM. How far advanced everything will be by the AGM 2013 date is, at present, impossible to say. I am sure that Diane will update us in Birmingham on 21 April. Meanwhile, I am sure that she has the appreciation, support and thanks from all of us. Very busy organizing the, hopefully, last steps in this operation, Diane has left me to tell you what is going on.

#### OTHER OPENING POINTS

🏂 This pre-Convention & AGM edition of FAN comes with the usual spring calls for volunteers, to cover many types of role including a call to bring new blood and ideas to the FA Board and to participate in the running of our Fellowship. This annual 'changing of the guard' gives others the chance of personal growth and to realize their untapped talent. Expectations as seen to "Today a Better Way"

Expectations can get us into trouble. If we are inclined to expect the worse, we may become sick with worry or paralyzed with fear.

Unrealistic expectations lead to disappointment: for example, expecting a particular result when we leave "helpful literature" where someone else will read it. Expecting total recovery from an addict who's been clean and so better offer three weeks, three months, three months or three years, can also set us up for a devastating plunge. Expecting too much from ourselves will often lead to grief; no one is perfect.

Perhaps the only safe expectation is that a Higher Power will bring about a correct solution, now or later, and that the answer to our prayers will be Yes, No, or Wait.

TODAY I WILL be open to the Juture rather than trying to create it by my expectations.

[February 18 reading in Today A Better Way, 6 Families Anonymous]

We learn in FA that expectations are something that can produce very adverse consequences, if they are not carefully kept within boundaries. Expectations are natural and have various roots. One of these roots could be our own false pride which might push us to aim for unrealistic or even unatalnable goals, not only for ourselves but also for the person that brought us to this programme. The enemy here can be our concern about what the neighbours, boss or even unaware family members think of us. Our programme suggests that, rather than succumb to these pressures, we look seriously at ourselves and replace false pride with humility, not to grovel, but to see ourselves in a true light in which the pressure to heighten our expectations subsides. We also learn that to have expectations of others can be a fulle exercise, and one which is likely to put us in line for disappointment. Attempting to control the situation, a right possessed uniquely by our Higher Power, puts us on the road to frustration. Setting up one's own expectations and encouraging others close to us to do the same, are both simply forms of fant

## **TOUGH LOVE in action**

As a member of Families Anonymous for many years, I have found many new ways of living my life: 'Let Go and Let God'; 'Detach with love';' Live a day at a time'.

I have been on the roller-coaster of having an addict in the family. My daughter made many demands on my time and purse and was the person who brought me to FA in the first place. I found a fellowship where I was not alone, where I was not judged, where people understood my emotions and where I could be truly honest. It took me nearly five years before I learnt to say 'No' and stick with it. I found a really good tool was to keep silent and not get caught up in argument or discussion or trying to justify my action or non-action.

It took a lot of effort from both myself and my daughter, especially when children were involved. We cut off contact from each other and her healing began. I started to understand what Tough Love meant. She is now in recovery and I am learning to behave in that situation.

Recently I had to face the challenge of Tough Love again where the outcome has been very different.

My son got involved with drugs at University, thinking he could stop whenever he wanted to: how often have we heard that before? His first and only job was extremely stressful as he was caught between 'the devil' (management) and ' the deep blue sea' ( the shop floor ) as he helped them to get their Quality Assurance recognition. His reliance on drugs escalated over the next 20 years as

he struggled with his addiction to heroin and alcohol.

In May he went into Rehab. When his partner and I visited after two weeks I saw my son of old: relaxed; chatty; smiling and positive. It gave us such hope. I then saw him weekly and rejoiced at his progress especially the times spent with his sister and nephew. I knew not to raise my hopes too high and when I returned from holiday he had returned home. Regretting the action he was accepted back at the Rehab but never settled again and did not fully engage with the programme.

After three months he obtained funding for further treatment but could not stay where he was. His partner set the boundaries for his return to their home — no drugs and no alcohol. By the Monday he had started drinking again, so she and I practised tough love. He had meetings set up and we suggested people who would help him with accommodation. He could not cope with this and took his own life.

This is something we all fear, the death of a loved one but FA has taught me that it was his choice and that I had to release him with love. My consolation is that he is now at peace. **From a Bristol member.**

I feel that the difference in me since taking up this challenge is significant. It is one of my blessings. I have grown; in confidence, outlook and self-worth. How marvellous that this has happened, and at the same time I have been able to give back to FA by giving Service. It has been

example of how feelings of fear and apprehension of the unknown, when faced, prove to be far less daunting in reality. I took the focus OFF my addict and thought about my own wellbeing for a change. I give my addict my love, and necessary detachment.

I gave myself a life. I value it. I am also aware that this is an on-going process of course. I have to be mindful that complacency can be detrimental.

I now plan to devote the time I have available to Public Information on a more local level and I

would like to say "Congratulations" to my successor.

Is anyone else hearing a niggling voice? Do yourself a favour and listen to it. You have NOTHING to lose!

Thank you FA for being there, for saving my sanity and giving me a future with serenity and understanding.







A long-standing member of the Queen's Park Group explained, before actually making the arrangements, that the group felt passionately about staging this event as an important aspect of twelfth step work. And so it was decided to host the Mini-Convention at St Luke's Church, London W9 on 24 November 2012 with the theme 'Tools of Recovery'. In advance, contact was made with NHS-run drug facilities in surrounding boroughs. The



Mini-Convention became a great talking point, a good reason to get in touch with these organizations, and has subsequently opened up a dialogue with some of the units.

On a general note, the Mini-Convention was a great success, with around fifty people benefitting from and enjoying the event, including out-of-town speakers and four new-comers. With careful planning, Queens Park group made sure that no demands were made on central funds, i.e. your donations. In fact, the event made a modest profit which was added to central funds afterwards.

**St Luke's Church** It was reported that, not only was there visible healing going on in the room, but it was further believed that this 'coming together' strengthened and revitalized the existing groups and certainly unified the host group in a common goal. Many Queens Park members had not done any wider service before, and the massive feedback from them witnesses how it feels to be of genuine 'use', or 'service' for the first time. The group feels that theirs is a model which might inspire others in different parts of the country. So, how was the event seen in the eyes of member of another London group who attended the event?

It was my first experience of a convention and I must say I was really touched by everyone's share, and was very pleased I made it there. My Westminster FA group is a very small and intimate group, which I love and that must be one of the reasons I've continued going there this long. Though it has its benefits of being small, it was an eye-opening experience to be in a room with lots of people sharing experience at the mini convention. I am ashamed to admit that I did not have courage to share mine at the time, but I learned a lot and very much encouraged to continue my recovery. 

#### **ROLE DESCRIPTION - SECRETARY**

This is an opportunity for an FA-member to become our next Secretary and for the applicant to repay what FA has done for him/her; a chance to find enjoyment, creativity and support as an FA Board Member.

#### **Useful Skills and Attributes:**

- Above all, enthusiasm, commitment and willingness to have a go at doing the job. Support and help will be available.
- · Familiarity with Microsoft WORD and email.

#### Location:

Attendance at board meetings in London and the AGM, wherever it is held.

There is no requirement beyond this to attend the office for this role.

#### **Role details:**

Ask for board meeting agenda items 4 weeks prior to the meeting, to include this in the agenda and circulate it in advance of the meeting via email.

Take the minutes at board meetings.

Prepare minutes as draft as soon as possible after the meeting and circulate them to all board members for comment prior to issuing final a copy.

Ensure any proposed amendments to the By-Laws are sent to Groups prior to the AGM.

Collaborate with the committee planning and hosting the FA convention and AGM to prepare and distribute key letters in accordance with the By-Laws.

Take the minutes at the AGM.

Prepare AGM minutes as draft as soon as possible after the meeting and circulate them to all board members for comment prior to issuing final copy.

Submit all minutes to the office for filing and circulation to group secretaries.

Prepare any letters as requested by the board

#### **Useful Skills and Attributes:**

- Above all, enthusiasm, commitment and belief in self to do the job, given support and help until confident.
- Very basic book-keeping skills to record and pay cheques into our account, pay incoming bills, volunteer travel expenses, printing etc, and keep filed copies of all transactions, bank statements and other invoices.
- Basic computer skills Microsoft EXCEL to update the monthly spread-sheet of income and outgoings. When we have PayPal up and running much more will be done online.

#### Location:

• It would be an advantage for the applicant to be able to access the office on a fairly regular basis, but no more than once or twice a month, to pay bills, volunteer travel expenses and such like.

#### **ROLE DESCRIPTION - FAN NEWSLETTER EDITOR**

This is an opportunity for an FA-member to become our next FAN-editor and for the applicant to repay what FA has done for him/her; a chance to find enjoyment, creativity and support as an FA Board Member.

#### **Useful Skills and Attributes:**

Above all, enthusiasm, commitment and belief in self to do the job, given support and help until confident. Basic computer skills will be needed from the start but willingness to learn is paramount. Familiarity with Microsoft WORD 2010 an advantage, but not a requirement.

#### Location

Where the applicant lives is irrelevant, as the preferred and experienced FAN-printer can deliver anywhere; access to a Post Office, large envelopes and sellotape are necessary - but are on hand in the Office in Battersea.

#### **Role details:**

Production of three editions of FAN per year, in spring, summer and autumn.

Useful Skills and Attributes:

Role details:

• Maintain stocks of existing literature by ordering items from the printers as necessary and helping with and overseeing in-house printing.

Stock control: After an initial stock lake, it is useful to record subsequent sales on the FA Office computer at regular intervals in order to maintain a picture of stock levels. All sales are recorded on receipted invoices and these can be the point of reference.

Ordering: The office volunteers send out free literature packs to people enquiring about FA – demand can fluctuate quite considerably. Some items are printed in house and others have to be carefully monitored and ordered from the printers in sufficient quantities to ensure permanently adequate supplies.

In-house production: Supplies to be checked of leaflets, slogans and other items produced in-house.

CDs to be copied.

The literature list (paper and on line) to be kept up to date.

Sub committee:

Should a new item of literature appear, it may be helpful to recruit another member for general discussion and/or 'translation' from US material and for proof reading purposes.

Keeping track of the stock can be done by whatever means — the office can be visited when convenient, a fortrightly or monthly visit should suffice — a London base, of either a sub-committee member or the applicant his/herself would be advantageous.
